

+Ordinance No. 12172020-2

TO REGULATE PARKING ON TOWN ROADS AND TOWN RIGHT -OF-WAYS

No Parking

The Town Board of the Town of Walworth, Walworth County, Wisconsin does ordain as follows:

Section 1. Purpose:

The purpose of this Ordinance is to establish areas in the Township of Walworth as "no parking" areas to be marked by traffic signs as "no parking".

Section 2. Authority

The Town Board of the Town of Walworth has the specific statutory authority and power, pursuant to Sections 349.06 and 349.1391(1), Wisconsin Statutes, to regulate, control prevent and enforce the stopping, standing or parking of motor vehicles on highways, roads, streets and alleys within the jurisdiction of the Town of Walworth

Section 3. General Provisions:

A. The authority to regulate the parking, standing and stopping of vehicles on all highways, roads, streets and alleys within the limits of the Town of Walworth, is hereby delegated to the Town Chairman of the Town of Walworth.

B. The Town Chairman of the Town of Walworth shall, in the interest of public health and safety, designate such highways, roads, streets and alleys, or any portion thereof he shall deem appropriate after consultation with the Town Board, as "no parking" areas. Any such areas so designated shall be marked with appropriate "no parking" signs.

Section 4. Enforcement:

The enforcement of this Ordinance in the Township of Walworth **will** be in accordance with Sections 66.12 and 345.20 through 345.53, Wisconsin Statutes. Stipulations shall conform to the form contained in the Uniform Traffic Citation and may be accepted within ten (10) days of the alleged violation. Stipulations and deposits may be accepted by the Town Clerk. Deposits shall be made in conformity with Section 345.26, Wisconsin Statutes.

Section 5. Penalty:

Any person violating this Ordinance shall be required to forfeit not less than Twenty Dollars (\$20.00) nor more than Forty Dollars (\$40.00) for the first offense, and no less than Fifty Dollars (\$50.00) nor more than One Hundred Dollars (\$100.00) for the second or subsequent conviction within one (1) year. In addition, under the provisions of Section 349.13(3), Wisconsin Statute, any motor vehicle found in violation of this Ordinance may be removed and any charges for removal or towing of such motor vehicle, as well as storage thereon, shall be paid by the owner or operator of such motor vehicle. Prior to release of the motor vehicle back to the owner or operator thereof, all towing, removing and storage charges shall be paid to the towing and/or storage company. No motor vehicles shall be released without the payment of these charges.

Section 6. Definition of Motor Vehicles

The term "motor vehicle", as used in this Ordinance, shall have the meaning set forth in Section 340.01(35), Wisconsin Statutes.

Section 7. Effective Date:

This ordinance becomes effective upon publication or posting in accordance with s. 60.80, Wis. Stats.
