ESTABLISHING A FEE TO RECOVER COSTS FOR EMERGENCY CALLS

Whereas, The Town Board of the Town of Walworth deems it appropriate pursuant to Wisconsin Statutes Section 60.55 and 60.557, as a Town with Village Powers, to establish a fee to recover costs for fire/rescue call responses.

(a) When an agency providing fire/rescue services under contract to the Town is called to provide service to a property owner, an individual, responding to a vehicle fire or accident on State, County and Town roads or an out of control called-in burn in the Town of Walworth, the costs of that service shall be charged to the property owner or individual according to a written fee schedule established by the Town Board as provided in Wis. Stats. 60.55(2)(b).

(b.) The costs of fire/rescue calls as outlined in subsection (a) shall be billed by the Town Clerk-Treasurer to the property owner/individual and paid to the Town Clerk-Treasurer within 60 days of the date of the bill. The failure to pay the bill within 60 days will result in interest being charged at the rate of one and one-half (1 ½) percent per month from the date of the bill. Those bills remaining outstanding, including interest, for more than 60 days as of November 1 of any year, shall become a lien against the real estate from which fire/rescue service was provided and shall be placed on the next tax roll as a delinquent special charge pursuant to Wis. Stats. 66.60. If needed, the Town Clerk-Treasurer is hereby authorized to use other collection efforts.

Passed by majority and roll call vote of the Town of Walworth Town Board and signed this 20th day of April, 2021.

Town of Walworth taxpayers shall be given a 25% discount for vehicle related emergency calls in the Town of Walworth

Motor Vehicle – Fire in large or commercial vehicle exceeding 25' in length	\$500.00
Motor Vehicle accident with Jaws of Life (extrication)	\$500.00
Scene control response (Need for blocking traffic or secure scene for non-fire reasons)	\$300.00
Dry Chemical – Extinguisher	\$ 75.00
Oil Dry \$20/per bag	
Foam	
First gallon of foam	\$100.00
Additional gallon of foam (per gallon)	\$ 50.00
Personnel per Firefighter/Licensed EMT or First Responder	\$ 30/hr
Smoke Alarms & Detection Systems	\$175.00
Structure Fire Call – 1 st hour	\$400.00
Cost per hour after 1 st hour	\$250.00
Hazardous materials response	Actual Cost
