**Ward 2**, County Board District 9, Population 454 and polling place at Walworth Town Hall, W6741 Brick Church Road, Walworth, WI 53184

**Ward 3**, County Board District 9, Population 426 and polling place at Walworth Town Hall, W6741 Brick Church Road, Walworth, WI 53184

**Ward 4**, County Board District 5, Population 220 and polling place at Walworth Town Hall, W6741 Brick Church Road, Walworth, WI 53184

WHEREAS, Wards 1, 2, 3 & 4 created above are hereby combined for voting purposes, so as to share the common polling place indicated and such combined wards shall use common voting machines and separate returns shall not be maintained for the combined wards at any election.

BE AMENDED as follows:





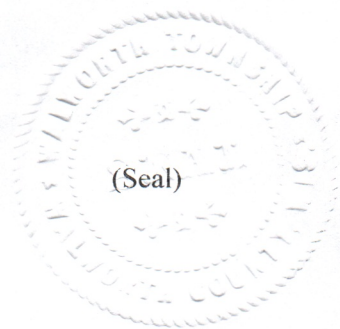

A Resolution to repeal and recreate Resolution 7192011-1 to establish Town Wards according to the 2020 census Adoption of Municipal Ward Plans for Voting Purposes

STATE OF WISCONSIN

Town of Walworth

Walworth County

WHEREAS, Wisc. stats 5.15, requires all towns with a population of 1,000 or more to establish municipal wards based on the results of the 2020 census, and

WHEREAS, 59.10(3)(b) of the Wisconsin State Statutes requires that each county board adopt and transmit to each municipal governing body in the county a tentative county district supervisory district plan, dividing the county into districts and designating the approximate location and population of each ward proposed to effectuate the division of the county into districts, and

WHEREAS, these laws require that each municipality designate by consecutive whole number, geographical description and population, the various wards to create within the municipality, and

NOW, THEREFORE BE IT RESOLVED, the Town of Walworth adopts the wards 1, 2, 3 and 4 as described as follows:

**Ward 1**, County Board District 9, Population 465 and polling place at Walworth Town Hall, W6741  
Brick Church Road, Walworth, WI 53184

**Ward 2**, County Board District 9, Population 454 and polling place at Walworth Town Hall, W6741  
Brick Church Road, Walworth, WI 53184

**Ward 3**, County Board District 9, Population 426 and polling place at Walworth Town Hall, W6741  
Brick Church Road, Walworth, WI 53184

**Ward 4**, County Board District 5, Population 220 and polling place at Walworth Town Hall, W6741  
Brick Church Road, Walworth, WI 53184

BE IT FURTHER RESOLVED,



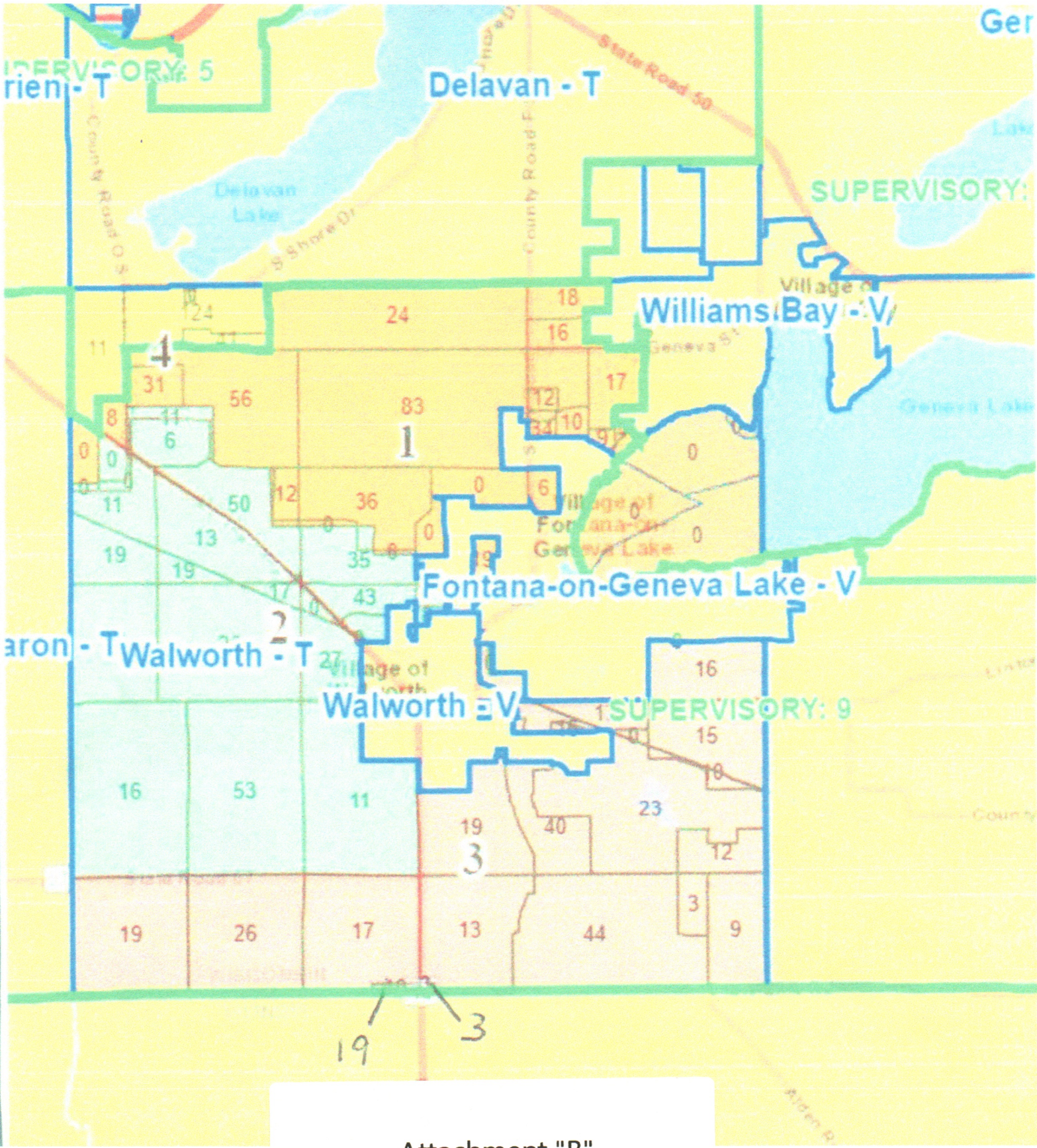
