## DOG LICENSES

State, County, and Town Laws require that all dogs 6 months or older be licensed. Please fill out one enclosed form for each dog you need to license. Licenses cannot exceed four per household unless permitted by zoning change.

### **Dog License Fees are:**

Altered male or female - \$14.00

Unaltered male or female - \$33.00

**Include** a self-addressed, stamped envelope for return of the dog license and tag.

**SEPARATE CHECKS** ARE REQUIRED FOR DOG LICENSES AND TAX PAYMENTS

**ALL DOGS MUST HAVE A RABIES VACCINATION TO BE LICENSED.**

**NO LICENSE without Rabies Certificate from Veterinarian with vaccine date, manufacturer and serial number.**

Failure to license your dog on time may result in fines.

## REMINDERS:

Moving snow onto the road or road right-of-way is prohibited.

**NO PARKING** is permitted on any Town roadway including subdivision streets and cul-de-sacs, between Nov. 1 and April 1, during any snow event of 2” or more until midnight on the second day following such snowfall.

The Town will not be responsible for repairing or replacing mailboxes if they are damaged during snowplowing operations.

### **BURNING**

When you plan a control burn, you must notify the Walworth County Sheriff's Department **(262) 741-4400** of the date, time and location of the burn. If you fail to call in a control burn and the Fire Dept. is called, the Landowner will be charged for the fire call. Charges will apply for out of control burns.
